FUNDRAISING TERMS AND CONDITIONS

- 1. Each child is expected to participate in fundraising activities.**
- 2. Each child will benefit from these fundraisers in the form of upgrades to equipment and other improvements to the league they participate in.**
- 3. The fundraising will be through sale of products or tickets towards the annual Chicken BBQ. Each child's goal is \$100.00 in gross sales for all fundraising activities combined.**
- 4. The annual Bar-Lyn fundraising goal will be \$7500.00 per year.**
- 5. Our fundraising goal needs to be met in order to keep traditional programs such as our annual year end banquet and championship coat program. If the goal is not met than we cannot afford to continue these programs.**
- 6. Meeting our fundraising goal will also help keep down registration costs, make necessary upgrades to equipment, train coaches and personnel to keep the kids safe and make the BarLyn youth football & cheerleading a more viable experience for this year and the years ahead of us.**

INSTALLMENT PAYMENT AGREEMENT

To help ease the burden of registration costs, the BarLyn organization is willing to accept 3 monthly installment payments for registration.

It is the responsibility of the agreeing party to ensure payments are made as scheduled.

Equipment will not be issued and jersey/cheer pack will not be ordered, until registration has been paid in full.

Registration fees paid in part, or in full, are non-refundable.

Payments will be 1/3 of total registration costs. (for example: if registration cost is \$75 your payment would be \$25 x 3 months)

****There will be a \$5.00 late fee assessed for payments not received by the due date. Late fees must be paid as part of the registration cost.**

Fee schedule is as follows:

1st payment due April 15th

2nd payment due May 15th

3rd payment due June 15th

PARENT VOLUNTEER PROGRAM

The board of directors and coaches of the Bar-Lyn Youth Football & Cheerleading organization are here for your children. We want the parents of this league to part of it as well. Please read the following and sign in the place provided.

It is understood that part of your child's football or cheerleading experience needs to have parent involvement. There are many tasks that need to be attended to on game days. A schedule of all tasks throughout the season will be filled in as registrations are taken.

Parents will be asked to provide a minimum of 4 hours volunteer time at some point in the season. Time slots are reserved on a first come basis. The 4 hours can be split among different dates.

NO SHOWS- Should a volunteer for what ever reason, fail to show for a reserved time, the child will not be eligible to participate at the following weeks activities.

It is the volunteer's responsibility to ensure their reserved time is covered. If you are unable to be there at the specified time, a substitute can cover for you.

- Board of director & coaching information changes annually. Contact information for these persons will be available at the beginning of each season.

Coaches & administrators:

- All coaches are to be certified and provide proof of this to the league.
- All persons involved with Bar-Lyn are volunteers.
- Board of directors are nominated and voted in annually.

Practice & Games:

- Practices begin at the end of July, the actual start date is TBD annually.
- Practices alternate weekly b/t Barker & Lyndonville.
- Practice times and days are set by the coaches.
- Games begin the week prior to Labor Day.
- We play an 8 game schedule with Labor Day weekend off.
- Times and places are dictated per the league schedule.
- Cheerleaders will be part of a league wide cheer competition.

Registration:

- Registration fees need to be paid in full prior to the first practice.
- Registration fees are non-refundable.
- Proof of recent physical needs to be provided.
- First year participants need to provide proof of their birth date. Any legal document showing date of birth is sufficient. (Birth certificate, school record)
- A portion of the registration cost covers the purchase of a jersey/cheer pack, which is for the participants to keep.
- The other portion of the registration fee covers insurance, administrative and other year end activities costs.
- In the event that fundraising goals are not met, a portion of the registration fee may be designated for other yearly budget needs.

Equipment:

- Bar-Lyn supplies the base equipment for participation. Additional equipment may either be required or recommended, which will be the responsibility of the participants.
- All equipment distributed by Bar-Lyn Football and Cheerleading is the property of the organization and is to be returned at the conclusion of the season. Items provided to participants as part of the registration cost (i.e. mouth guards, jerseys, cheer packs) are property of the participant.

Fundraising:

- Each child is expected to participate in the fundraising program.
- Each participant's goal is \$100 in sales.
- The annual goal for the organization is \$7500.00.
- Prizes are awarded for the top sellers.
- Proceeds from fundraising cover football & cheerleading equipment purchases & upgrades.
- The percentage of fundraising completed will be considered when planning year end events. (Banquets, team parties, championship awards, etc.)
- Donations (raffle items, bake sale, cash) outside of the designated fundraising program, will be considered as part of the program goal.

Volunteers:

- Parent volunteering is MANDATORY. Please refer to Parent Volunteer page.
- A sign up sheet will be provided for different areas in which to volunteer an hour or two of time during home games.
- We understand everyone wants to see their child's game, generally kids are asked to be at the field 1 ½ hours prior to game time for warm ups. Use this as time to volunteer.

Parental behavior:

- Only authorized persons are allowed on the sidelines during games. Bar-Lyn submits a list of coaches and other authorized sideline personnel to the league. If you are not on the list you are in the stands.
- Persons are to refrain from foul or abusive language.
- Abusive comments or actions toward referees, players or coaches will not be tolerated.
- Teams can be penalized during games for "bad fan behavior".
- Alcohol or tobacco use on school property is not allowed. (Home or away).
- Violators will be asked to leave the premises.
- Remember your actions will reflect not only on yourself personally, but your family and the Bar-Lyn organization. Let's keep the experience positive.

Comments/Complaints:

- Bar-Lyn cares that your child has a positive experience while participating. Any comments or suggestions help to improve this organization.
- Complaints- If you see something that you feel is out of line please let the Bar-Lyn administrators know. We will take corrective steps to address the situation. Formal complaints need to be in writing.
